

Corporate Governance Diversity

Abstract

In an equilibrium setting, governance is an interdependent strategic choice. This paper considers the equilibrium choice of corporate governance in an oligopolistic market when firms choose governance structure as a strategic response to competitors' governance. Using this model, we make predictions regarding the second moment of governance distribution. We show that variation in governance is higher in less competitive industries. Variation decreases as investor protection improves.
